5. Guest Speakers from ECSD Educational Planning Department - Jolene Thompson and from KJ Street Consulting (Grant Writers) - Kim Street; to speak to our Playground Update and Grant applications. We are not going to be able to use the existing playground space for our new park. That park is on Edmonton Public Schools' Land and therefore, even with permission, Edmonton Catholic will not put funding into development not on their land. We will need to build our new park on our land somewhere. The old park will remain as is until it is deemed to have reached the end of its life span and will then be torn down. With this shift, Kim and Jolene are very optimistic that we will be successful in our current application for CFEP funding. We should hear before Christmas about our application. Once we are successful, it is often that additional funders will come forward and we will have even more funding available. Because we have our share raised and ready to go and we are not trying to build on the existing park there should be no more issues. We are their priority for support and if we do not get the funding, then the plan is for them to meet with our MLA to discuss the park and how to move it ahead. If we do hear that we are approved, then planning and development will be a push and hopefully fences will go up the last day of school and a new park can be up before the next school year. We will restart our park subcommittee to meet with developers and choose the designs. Questions asked about building costs and if they have gone up is a budget of 250 000 going to be enough. Kim and Jolene feel that is a decent budget and will build a nice new park. We discussed surfacing for the park. Sand is no longer used so minimally the surfacing would be woodchips. Rubberized surfacing can be quite expensive, but a blended surface is also something to
