4.1. Playground Update

- Blue Cross grant application was not successful Edmonton Public Schools won that one.
- CFEP successful! We already have the money! We can build the park this year!
- Walmart community grant for \$1,000 application was submitted January 5th
- AGLC funds need to be spent within 36 months of being received. Last Casino funds were received in August of 2022. This means we will not
